Some near-term goals of Operation “man-caused global warming:”

- ♦ Cap and Trade legislation (as per the Climate Security Act and Kyoto Protocol-type legislation)
- ♦ Establishment of cap and trade-type carbon trading on the Chicago Climate Exchange and similar mechanisms
- ♦ Use of environmentalism as substitute for war (to maintain social structure and destroy 10 to 15% of GDP as per “The Report from Iron Mountain” in 1967, (Abraham, 1993))
- ♦ Justification for geoengineering, including weather warfare and military black ops that use Tesla technology, i.e., directed energy weapons, scalar technology, etc.)
- ♦ Exercise of total political control through control of space and by applying techniques of (deniable) weather warfare on non-compliant nations
- ♦ Incremental depopulation as per stated U.N. goals and U.S. policy documents such as National Security Memo

Cap and Trade

- ♦ Man-caused global warming as an excuse to impose “carbon taxes” such the Cap and Trade provisions of laws such as the Climate Security Act.

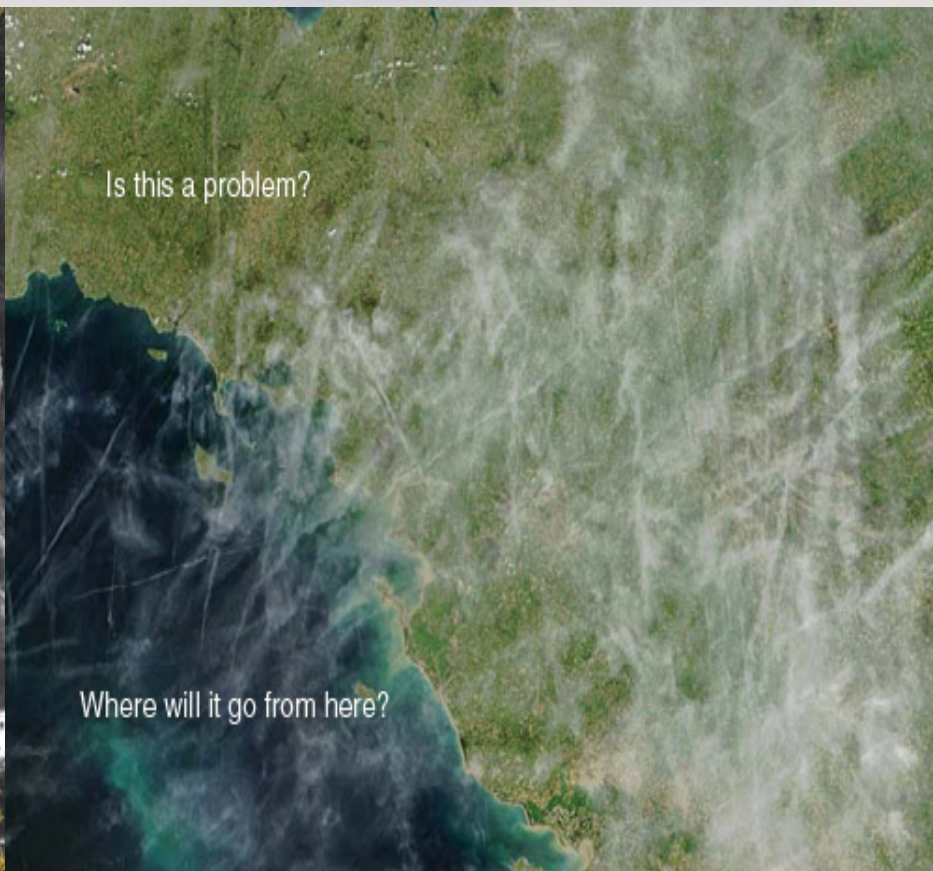
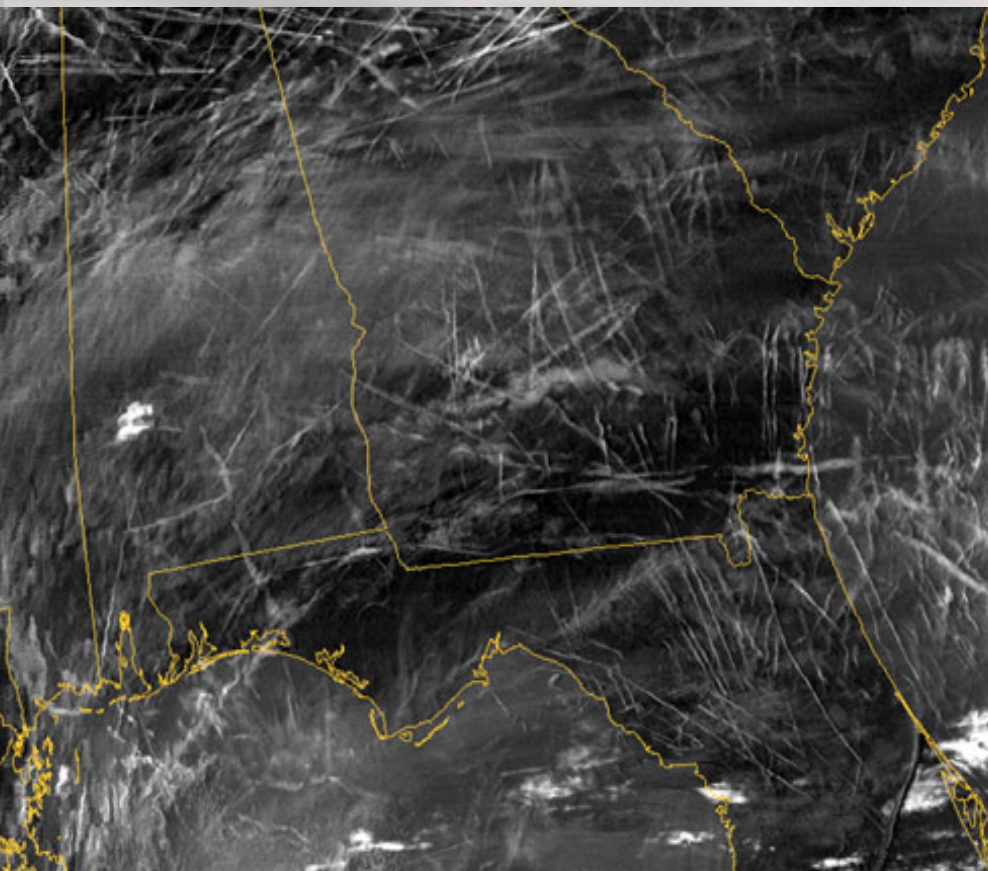

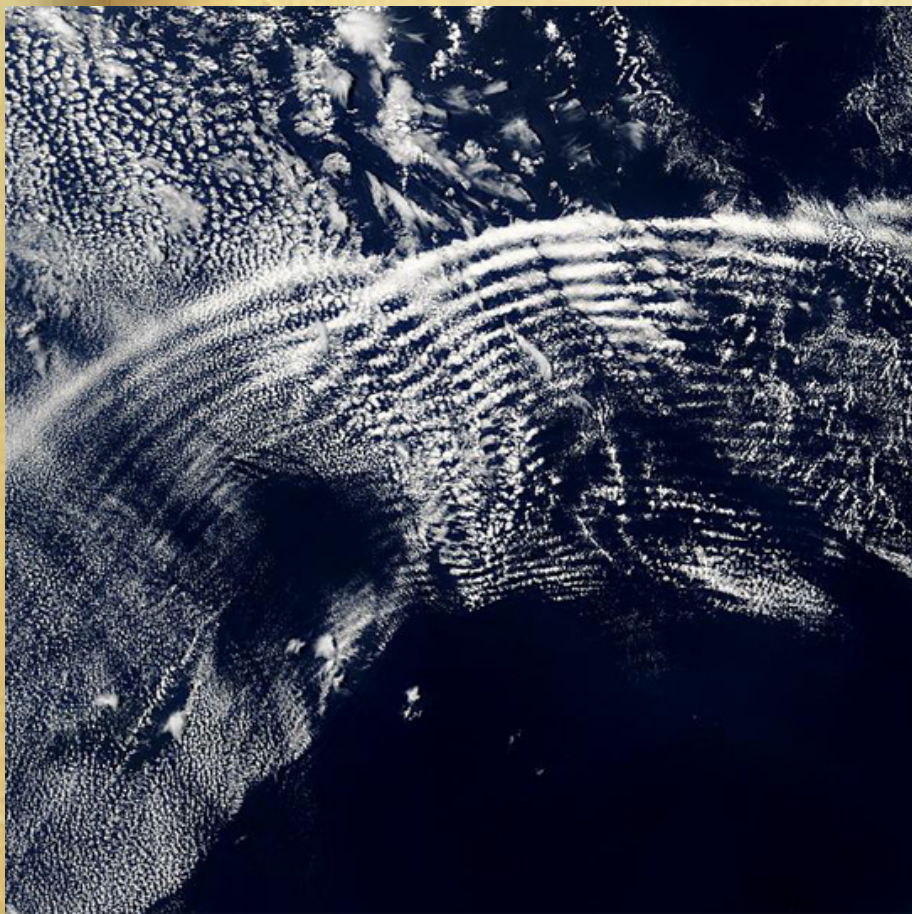

cause “scalar” effects in the sky:**



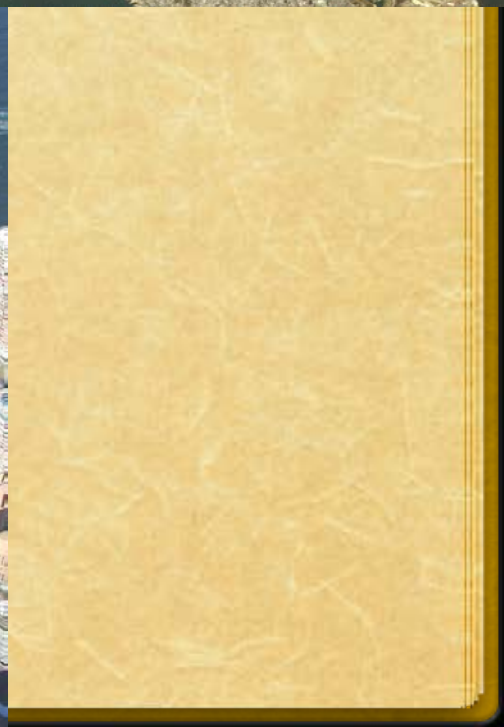

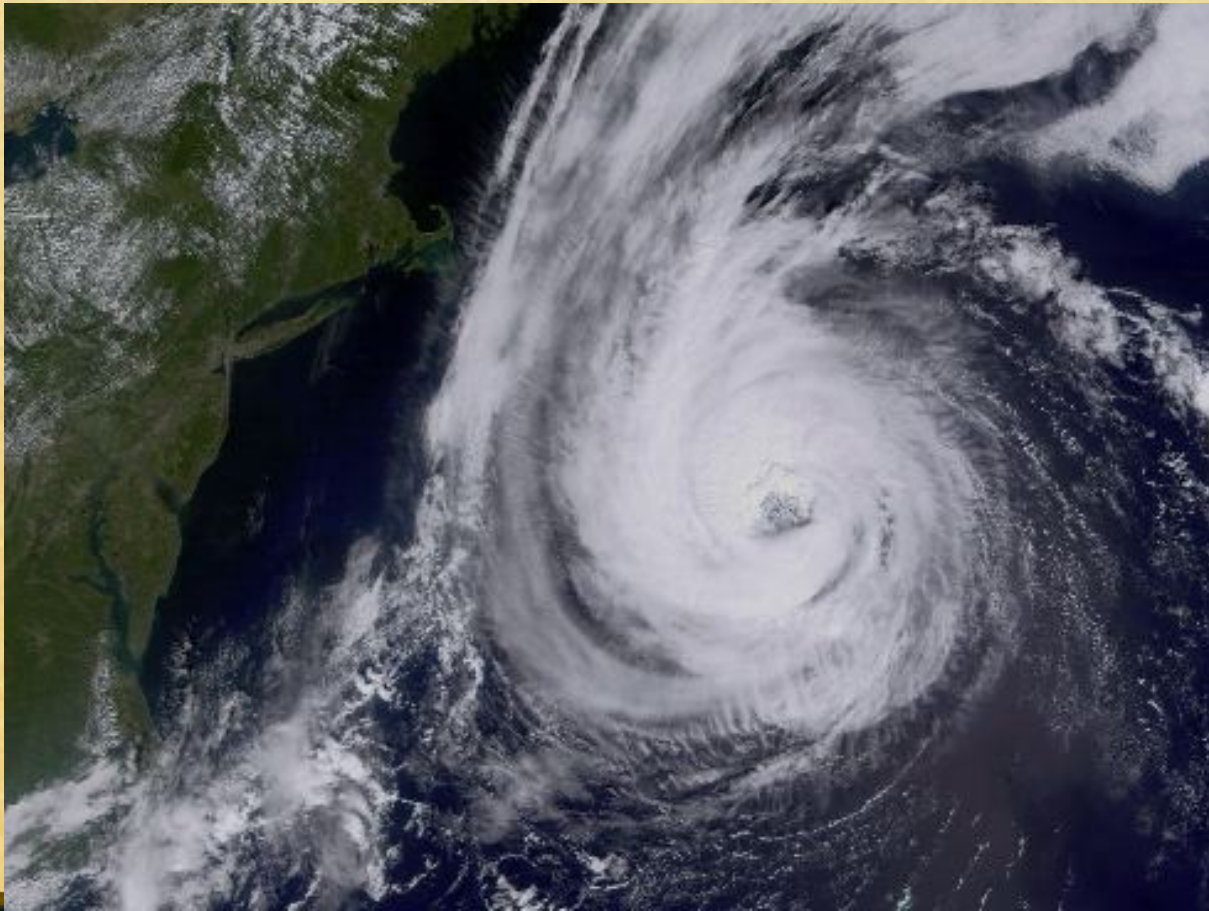
